SUBJECT: Dress and Appearance Policy Letter for Georgia Pines Dining Facility

1. In order to maintain a pleasant and sanitary atmosphere, the following dress code applies to all personnel who utilize the dining facility.


a. Military attire:

(1) Military uniforms *must* be in compliance with AFI 36-2903, *Dress and Personal Appearance for Air Force Personnel*, and the appropriate directives which prescribe the wearing of the military uniform for all other service members. An example of uniform wear that is not within regulations includes, but is not limited to **permanently stained or ripped blouse or trousers**.

(2) Military headgear is *not* to be worn inside the dining facility except in the performance of duties by armed security forces, fire department, military public health, and food service workers.

b. Civilian attire: Appropriate civilian attire that presents a positive military image is permitted. Examples of *inappropriate* civilian attire include, but are not limited to: **Shower shoes, bedroom slippers, bare feet, exposed undergarments, extremely short shorts, sports bras, sweaty or dirty clothing, sleeveless shirts, or any attire that is profane, obscene or could otherwise bring discredit to the integrity or professionalism of the Air Force.**

SUBJECT: Authorized Patrons Letter for Georgia Pines Dining Facility

1. Authorized Patrons: In accordance with AFMAN 34-240, *Appropriated Fund (APF) Food Service Program Management*, where such permission does to degrade the ability to serve our Essential Station Messing (ESM) customers, the following categories of personnel are authorized to utilize the Georgia Pines Dining Facility:

- a. All active duty enlisted personnel.
- b. Active duty officers (on a quarterly basis) to determine the quality and quantity of food served to their enlisted personnel.
- c. All Temporary Duty (TDY) personnel with orders authorizing or directing use of government dining facilities (Non-ESM personnel must present their orders to cashier).
- d. Reservist trainees, Reservist officers and enlisted on Title 10 orders.
- e. On-duty emergency responders and security personnel (civilian, contractors, and DoD).
- f. Special dignitaries, including civilian, military and foreign government personnel.
- g. Retirees (all ranks and services) and immediate family members (only on weekends and holidays).
- h. Spouses and dependent children of active duty personnel (E-1 to E-4) during permanent change of station (PCS) while utilizing on-base billeting; PCS-in (10 days) or PCS-out (10 days).
- i. Family members and volunteers that are attending Airman and Family Readiness Center sponsored events that include Hearts Apart, etc.

2. Please note that during contingencies, access may be limited to mission-essential personnel only.
